TERMS AND CONDITIONS FOR CONTACT

Terms and conditions for the disposal of vehicle of office of the Chief Electoral Officer, Punjab are as under: -

1. The earnest money to be submitted by the tenderer along with his tender shall be 10% of the reserve amount for respective vehicle. The vehicle shall be disposed of to the highest bidder, in case the highest bidder does not lift the vehicle within the period of 72 hours after his bid has been accepted (after excluding the holidays, if any) the earnest money shall be forfeited and the vehicle shall be offered to the next higher bidder, and so on.
2. The vehicle can be inspected on any working day between 10.00 AM to 04.00 PM from 1st Feb., 2021 to 16 Feb., 2021 at the office of the Chief Electoral Officer, Punjab, SCO No. 29-32, Sector: 17-E, Chandigarh.
3. The tender would be accepted as per the terms and conditions of the tender and no further condition by bidder of any kind shall be accepted.
4. That only one tender from alongwith earnest money of 10% of the reserve amount shall be used for three vehicles. If tenderer is bidding for more than one vehicle, he will submit the earnest money for each vehicle separately through demand draft in favour of Electoral Officer, Punjab payable at Chandigarh.
5. The conditional tenders shall be straightway rejected. Any incentive linked with the rates shall be treated as conditional.
6. The tender form shall be filled with as typed or in ink words and figures, any tender form filled with pencil shall be rejected
7. The earnest money shall be given vehicle wise and the earnest money shall accompany the tender form in the shape of bank draft, otherwise the offer shall be rejected.
8. All the taxes as applicable shall be paid by the successful tenderer himself.
9. The password protected tenders received through email should also be entertained. In this case tender has to deposit the tender form fee Rs. 500/- along with 10% required earnest money of vehicle in the official bank account of Additional Chief Electoral Officer, Punjab SB No.: 39931333375, IFSC: SBIN0000628. The tender will mention the UTR
